EMPOWER Program Contract

The HRA of Hibbing is a Moving to Work (MTW) designated agency. This means the HRA has a unique ability to operate a program that helps residents achieve self-sufficiency. The HRA defines self-sufficiency as the ability of residents to successfully maintain the health, financial and personal outcomes necessary for graduation from public housing.

To achieve this goal, the HRA has the EMPOWER Program. The EMPOWER Program prepares households through health, financial and personal programming for the eventual goal of graduation from public housing to fair-market rental or private homeownership.

The EMPOWER Program and its requirements are mandatory for all nondisabled residents of the HRA between the ages of 18 and 62. EMPOWER Program requirements include, but are not limited to, regular meetings with the MTW Coordinator and other EMPOWER presentations or events which are clearly communicated by the MTW Coordinator in advance.

The HRA of Hibbing has established a “Three-Strikes” rule. If I miss (no call/no show) three (3) required components of the EMPOWER Program, my lease is liable to be terminated. Each missed meeting will be followed up with a letter and call explaining the consequences of future missed meetings.
